Safety Net - The Safety Net Tech team focuses on the intersection of technology and intimate partner violence, including its impact on safety, privacy, accessibility and civil rights of victims. In 2016, our Safety Net team trained 6,429 practitioners on technology topics, including safe victim relocation, technology and confidentiality, and enhancing victim services through technology. We also hosted an annual Technology Summit, a 4-day conference that brought together 250 advocates, victim service providers, law enforcement professionals, attorneys, faculty, and tech companies from across the United States and 5 countries (Australia, United Kingdom, Canada, Holland, and Ireland) to address the

Capacity Building-NNEDV's Capacity team provides comprehensive, specialized training and technical assistance to the 56 state and territorial domestic violence coalitions, as well as other service providers, so that they can best address the needs of victims and local domestic violence shelters and programs, and lead efforts to end violence in their states and territories. We host regional meetings and an annual Roundtable meeting to enhance best practices, provide training and peer education, and share resources. We also support new leaders with peer-Executive Directors mentoring and coaching. We provide assistance on a wide range of topics, including organizational development, board development, evidence-based practices, crisis management, trauma informed care, disaster response, and increasing access to victim-centered and culturally appropriate services.

Housing-NNEDV's Housing Project works with the Department of Housing and Urban Development (HUD) and other stakeholders to advance policies that support domestic violence survivors' housing rights and increase victim access to safe housing, including emergency shelter and transitional housing. The project also provides training, program and policy development, and consultation on best practices to hundreds of domestic violence transitional housing programs across the US. In 2015, we added an initiative to determine how to best meet the needs of sexual assault victims who are in domestic violence transitional housing.
